The breaching party is responsible for all legal expenses. If the above-described animal is bred while this private agreement is in effect, ownership and physical possession of the animal and all offspring shall immediately revert to **Jennifer Bender** with no compensation to the adopter.

**I will not breed the above-described animal. I understand if I breed the above-described animal on purpose or by accident, will constitute a violation of this private agreement. Set fines mentioned above are due and payable immediately to Jennifer Bender.**

The above-described animal has a 72-hour health guarantee (equivalent of three days) if the animal is taken to the vet within 48 hours of arrival for a healthy check or sooner if the animal is showing signs of illness. All fees, tests, and vet bills are responsibility of adopter, unless noted below. The above-described animal must NOT be in contact with other animals during the warranty period. Failure to comply will void the health guarantee. Should the above-described animal become ill within 72 hours do to parasites or a similar condition that is directly related to **Jennifer Bender** or her establishment, plus the glider has not been exposed to any other animals, **Jennifer Bender** will pay vet bills directly related to the medical condition. A medical exam will be needed by a qualified vet to prove illness and its origin. Should the above-described animal pass away within the 72 hours do to parasites or a similar condition that is directly related to **Jennifer Bender** or her establishment plus the glider has not been exposed to any other animals, the adopter has the right to receive a refund for the purchase of the sugar glider only (excludes shipping/transportation fees), or a replacement of the animal with the next available animal at adopters choice. A medical exam/necropsy will be needed by a qualified vet to prove a covered illness at the expense of the adopter.

Trauma, stress related illnesses, and bacterial infections are NOT covered. Adopter is responsible to for watch for stresses or stress symptoms. Should symptoms arise, adopter is responsible to get the animal to the vet immediately. All vet bills incurred for stress related illnesses will be the responsibility of the adopter.

**\*\*\*This health guarantee does not cover accidents, neglect, or mistreatment of any kind.\*\*\***

The adopter agrees that he/she will not sell, giveaway, or otherwise dispose of said animal to any person(s), dealer, retailer, auction, institute or any other entity or abandon said animal for any reason. If at a later date the adopter is unable or unwilling to keep above-describe animal he/she agrees to first contact **Jennifer Bender** to buy back the pet at 50% of the original adoption fee or the current market value (whichever is less) plus actual shipping/transportation charges if required. If **Jennifer Bender** is unable or unwilling to reclaim the above-described pet, the adopter will place the pet privately as a pet only or place via a responsible pet rescue.

The adopter hereby agrees to care for the above-described animal in a humane and responsible manner and to provide it with clean and adequate shelter, food, water, and veterinary care if the animal becomes ill or injured.
